

**I am in receipt of a Docket that is not mine, as its designation is Docket No. C-2018-3007622. And it's sealed and signed by Rosemary Chiavetta, Secretary of the Pennsylvania Public Utility Commission. But the Secretary is not an officer of the court and legally is not entitled to sign this Order.**

**The Opinion & Order received is similar to filings I have submitted since 2019, but with this gross incompetent error. Do I file a Motion for Dismissal and force the PAPUC to meet again? 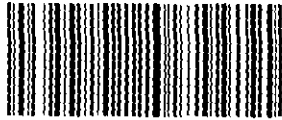
