Dear Secretary Chiavetta:

This letter serves as the compliance filing in accordance with the Opinion and Order entered September 4, 2024 (“Order”), in the above-referenced proceeding. Pursuant to Ordering Paragraph 4 of the Order, PPL Electric Utilities Corporation (“PPL Electric” or the “Company”) has performed a billing adjustment for Mr. Sang Choe’s (“Complainant”) residential electric account at 53B Pennwick Drive, Lititz, PA 17543 (“Service Address”), calculated by multiplying the average daily usage between August 2021 and August 2022, by the number of billing days in each corresponding billing period between August 2022 and August 2023.

The aforementioned billing adjustment resulted in a refund being issued to the Complainant in the amount of \$952.23, provided to the Complainant in the form of a check via Federal Express overnight shipping on October 3, 2024. This refund was derived by applying the applicable price-to-compare (“PTC”) for each relevant billing period’s ordered refunded consumption amount. In total, PPL Electric refunded the Complainant \$952.23, or the applicable periods’ PTCs for a sum total of 5,885.4 kilowatt-hours (“kW”). Additionally, PPL Electric notes that the Order required PPL Electric to waive all late payment fees incurred by the Complainant between August 2022 and August 2023. There were no late payment fees levied during that time, thus, none have been waived.

PPL Electric will test the Complainant’s meter at the Service Address, provide the Complainant with the results of the test, and submit notification of the same to the Commission by the date prescribed in the Order.
