ALJ Ashton has asked me to notify you that PGW's request for a continuance is granted. However, the further telephonic hearing scheduled for Tuesday September 3, 2024, will be converted into a prehearing conference.

Both parties will be expected to appear for a prehearing conference on Tuesday September 3, 2024, at 10 am for the sole purpose of discussing whether the parties feel they have created a sufficient record in this matter and whether a further hearing in this matter is necessary or appropriate. No witnesses need appear at the conference; however, a court reporter will be available to document the discussion at the prehearing conference.

ALJ Ashton also asked me to convey to you that:

- the hearing was scheduled pursuant to an Order issued on August 5, 2024, by Judge Heep in this matter
- Judge Heep's order specifies that "Issues to be addressed are the charges for the second-floor unit for the period 2020-2024 and the inspections that are the subjects of PGW Exhibits 14-15."

If neither party does not wish to participate in the prehearing conference on September 3, 2024, or a further hearing, they may advise ALJ Ashton of that decision in writing via email prior to the September 3, 2024, prehearing conference.
