**POST-HEARING ORDER**

On October 1, 2024, an evidentiary hearing was held in the above captioned matters. UGI Utilities, Inc. – Electric Division (“UGI”), the Office of Consumer Advocate (“OCA”), the Office of Small Business Advocate (“OSBA”), and Penn Renewables, LLC (“Penn Renewables”) participated in the hearing. Two UGI witnesses and one Penn Renewables witness were cross-examined during the hearing. UGI, OCA, OSBA, and Penn Renewables each moved to have their witnesses’ testimony and exhibits entered into the record. As there were no objections, all parties’ proffered testimony and exhibits were admitted into the record during the hearing. UGI, OCA, and OSBA indicated that they had reached a Non-Unanimous Settlement in this matter (with Penn Renewables currently opposed to the Settlement). Deadlines and instructions concerning the filing of Briefs and documents related to the Settlement were discussed during the hearing. This Order memorializes the deadlines and instructions for the submission of these documents.

ORDER

THEREFORE,

IT IS ORDERED:

1. That the Petition for Settlement, along with Statements in Support or Non-Opposition from all signatories, shall be filed **on or before October 22, 2024.**

2. That any written opposition to the Settlement shall be filed **on or before October 25, 2024.**

3. That the parties shall file and serve **main briefs on or before October 15, 2024, and reply briefs on or before October 25, 2024.**

4. That the parties must comply with 52 Pa. Code §§ 5.501, et seq., regarding the preparation and filing of briefs. Service can be made electronically by no later than 4:30 p.m. on the dates listed. Parties are directed to e-mail us searchable copies of their as-filed briefs in ADOBE or other compatible PDF format in addition to a WORD-formatted document. The format of the briefs served electronically on the parties may be as requested by the parties.

5. That, in addition to the mandatory contents set forth in 52 Pa. Code § 5.501(a), all main briefs, regardless of length, must contain:

- A. A table of contents;
- B. A history of the proceeding;
- C. A discussion;
- D. Proposed findings of facts (with record citations to transcript pages or exhibits where supporting evidence appears);
