MOTION FOR DEFAULT JUDGMENT

NOW COMES the Pennsylvania Public Utility Commission’s (“Commission”) Bureau of Investigation and Enforcement (“I&E”), by its prosecuting attorney, and files this Motion for Default Judgment against Gracies Transportation Service, LLC (“Respondent”) pursuant to Section 5.103 of the Commission’s regulations, 52 Pa. Code § 5.103. In support thereof, I&E respectfully represents as follows:

1. I&E commenced this action on February 14, 2024, by filing an assessment-related Complaint.
2. The Complaint alleged that Respondent violated Section 510(b) of the Public Utility Code, 66 Pa.C.S. § 510(b), by failing to file completed assessment reports for the 2020, 2021, and 2022 calendar years.
3. The Complaint also alleged that Respondent violated Section 510(c) of the Public Utility Code, 66 Pa.C.S. § 510(c), by failing to satisfy its 2022-2023 and 2023-2024 Fiscal Year assessments in that it did not pay the amounts due within thirty (30) days of receipt of each Assessment Invoice.
4. On February 14, 2024, the Complaint was served by certified mail at P.O. Box 14728, Philadelphia, PA 19134, which is the last known mailing address that Respondent provided to the Commission.

5. Attached to the Complaint was a Notice advising Respondent that it must file an Answer within twenty (20) days of service of the Complaint.

6. The Notice also advised Respondent that if it failed to answer the Complaint, I&E would request that the Commission issue an Order imposing the penalty set forth in the Complaint.

7. On March 12, 2024, the Complaint was returned to the Commission as undeliverable.

8. Also on March 12, 2024, I&E filed a Motion for Default Judgment against the Respondent.

9. On March 20, 2024, the Secretary's Bureau attempted to reserve the Complaint on the Respondent by certified mail at 956 East Main Street, Collegeville, PA 19426, a secondary address provided by the Respondent to the Commission as the Respondent's "physical address."

10. Although the Complaint served on March 20, 2024, at the Collegeville address was not returned to the Commission, there was no indication that the Complaint was received by the Respondent.

11. On May 20, 2024, the Honorable F. Joseph Brady, Administrative Law Judge, stayed the proceeding until such time as service could be made on the Respondent either by certified mail in accordance with 52 Pa. Code § 1.53(c) or publication in a newspaper of general circulation or the *Pennsylvania Bulletin* in accordance with 52 Pa. Code § 1.53(e). ("May 20, 2024, Stay Order").

12. On September 7, 2024, notice of the Complaint was published in the *Pennsylvania Bulletin*, effecting service in accordance with 52 Pa. Code § 1.53(e) and Ordering

Paragraph 3 of the May 20, 2024, Stay Order.¹

13. Included in the publication of the Complaint in the *Pennsylvania Bulletin* was a Notice advising Respondent that it must file an Answer within twenty (20) days of service of the Complaint.

14. The Notice also advised Respondent that if it failed to answer the Complaint, I&E would request that the Commission issue an Order imposing the penalty set forth in the Complaint.

15. The twenty (20) days to file an Answer to the Complaint expired on September 30, 2024.

16. Respondent did not file an Answer to the Complaint.

17. Pursuant to Section 5.61(c) of the Commission's regulations, a Respondent who fails to file an Answer to a Complaint within the 20-day response period may be deemed in default, and the relevant facts stated in the Complaint may be deemed admitted. 52 Pa. Code § 5.61(c).

18. The Commonwealth Court has upheld the Commission's authority to sustain complaints that are not answered within twenty days. *See Fusaro v. Pa. Pub. Util. Comm'n*, 382 A.2d 794, 797 (Pa. Cmwlth. 1978).

19. Respondent did not pay the total outstanding assessment balance of \$36.00 for the 2022-2023 and 2023-2024 Fiscal Years or the civil penalty of \$1,700² that was sought in the

² This civil penalty is based on a review of Respondent's history of compliance with the Public Utility Code and Commission regulations and orders for three years prior to the date that I&E filed its Complaint in this matter, the need to deter future violations, the amount of Respondent's outstanding assessment balance for the 2022-2023 and 2023-2024 Fiscal Years, and prior Commission decisions in similar situations pursuant to 52 Pa. Code §§ 69.1201(c)(6), (8), and (9).

Complaint for Respondent's failure to pay its 2022-2023 and 2023-2024 Fiscal Year assessments and to report its gross intrastate operating revenues for the 2020, 2021, and 2022 calendar years.

20. I&E respectfully requests that the Commission enter a Default Order against Respondent that:

- a. Directs Respondent to pay a total of \$1,736.00, which consists of its outstanding assessment of \$36.00 and the requested civil penalty of \$1,700.00 within thirty (30) days of the entry date of the Commission's Order;
- b. Directs the Bureau of Technical Utility Services to cancel Respondent's Certificate of Public Convenience at A-2014-2438361 if Respondent fails to pay the total set forth in subparagraph (a), above, within thirty (30) days of the entry date of the Commission's Order;
- c. Notifies Respondent that a copy of this Order will be sent to the Pennsylvania Department of Transportation for the suspension or revocation of vehicle registrations that were used under Respondent's operating authority if Respondent fails to pay the total set forth in subparagraph (a), above, within thirty (30) days of the entry date of the Commission's Order; and
- d. Directs the Bureau of Administration, Assessment Section, to refer the matter to the Pennsylvania Office of Attorney General for collection of the total set forth in subparagraph (a), above, if Respondent fails to pay that total within thirty (30) days of the entry date of the Commission's Order.
