

Answers to Request for Information Related to Question #5 of the Verified Statement of the Applicant

All drivers to be used by the Applicant must be at least 21 years of age. The company policy will be that any drivers hired to provide transportation under the limousine authority of the Applicant must be 21 years of age or older.

In addition, a criminal history record will be obtained by the Applicant from the Pennsylvania State Police for all drivers to be employed who will be residents of Pennsylvania. Applicant will obtain a criminal history record for each driver every 2 years. Any applicant who has been convicted of a felony or misdemeanor that would relate adversely to the driver's suitability to provide service such as crimes involving the use or sale of narcotics, theft, or involving physical or sexual assault. Moreover, drivers will be prohibited from use of alcohol or controlled substances while operating a vehicle for the Applicant. The company will maintain a driver file for all drivers hired which will contain all information involving the driver for at least 3 years.

As the owner of Black and Gold Transportation, LLC, I will personally test and train all drivers who apply for employment or who desire to drive for the Applicant. This will involve road testing as well as testing the driver's knowledge of PUC regulations. In addition, an annual check of the driver's license and driving history will be conducted. In addition, periodic random checks will be performed annually.

There is attached to this statement a financial statement for Black and Gold Transportation, LLC. This is a newly formed entity and does not have any physical assets including motor vehicles. However, the owner of the Applicant has advanced cash to the LLC as reflected on the attached financial statement. The financial statement includes all funds advanced to the company by the owner to form the LLC and for operating capital. Attached to the Applicant's financial statement is a copy of The Chase bank statement dated Oct. 2, 2024 Applicant's owner is prepared to advance additional funds to Applicant if necessary.



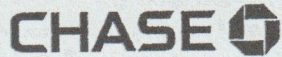
