Enclosed please find Seneca Resources Company, LLC's *Amended Act 127 Pennsylvania Pipeline Operator Annual Registration Form – 2023* to be filed at the above-referenced docket. Seneca submitted its original registration form and payment on or about March 27, 2024. While conducting an evaluation of our pipeline classifications based on the new USDOT regulations, we recognized that the MAOP for a number of pipelines was reduced for a number of pipelines to 125 PSIG or lower requiring a change of classification from Type C to Type R. Rather than waiting to update these classifications with our annual report for 2024, we believed it to be more prudent to submit an amended form to the Commission.
