On October 4, 2024, Sunoco Pipeline L.P. (Sunoco Pipeline) filed an Application for Abandonment of a Portion of Its Petroleum Products Pipeline Transportation Service within Pennsylvania from Salem, Chelsea, and Twin Oaks to Willow Grove. The Application was incomplete. In order for us to complete our analysis of your application, the Energy Industry Group requires answers to the attached questions.

Please forward the requested information to the Secretary of the Commission **within 30 days** from the date of this letter. Failure to respond may result in the application being denied. As well, if Sunoco Pipeline has decided to withdraw its application, please reply notifying the Commission of such a decision. All documents requiring notary stamps must have original signatures. The Commission strongly encourages submission through efilings with the Secretary of the Commission by opening an efilings account through the Commission's website and accepting eservice at <https://efiling.puc.pa.gov>. The Commission is accepting all public documents through our efilings system at this time.

If your filing contains confidential material, you are required to either file by overnight delivery or submit to the Secretary's Share Point File system to ensure the timely filing of your submission. Filers should contact the Secretary's Bureau in advance to gain access to the Share Point File system. Make sure to reference the Docket Number listed above when filing your response and mark the materials "CONFIDENTIAL" in



- 1) Reference Application – Introduction. Please explain if the company is seeking to abandon any pipeline facilities associated with the Willow Grove delivery point abandonment.

If so, provide:

- a) Age, material and installation dates of these pipeline facilities.
 - b) Inspection and leakage or pressure testing reports, overall condition of these facilities.
- 2) Reference Application – Paragraphs 5, and 9. These sections state that the delivery point of Willow Grove has not been used and has not generated any revenue in the past approximately 13years. Does the company incur any expenses in maintaining this delivery point? If so, please provide the annual cost for the last 5 years.
 - 3) Reference Application – Exhibit A. The attached map indicates the location of Willow Grove and Twin Oaks. Please provide a map that shows the locations of Salem and Chelsea.
