In accordance with 52 Pa. Code §29.505(b)(1), the Applicant will conduct a local and national criminal background check for each driver applicant. The Applicant understands that the background check must include a multi-state or multi-jurisdictional criminal records locator or other similar commercial nationwide data base with primary source search validation and a review of the U.S. Department of Justice National Sex Offender public website. Applicant will endeavor to comply with this criminal background check regulation for all drivers.

A driver would be disqualified for driving under the influence of drugs or alcohol, a felony conviction involving theft, fraud, or a violation of The Controlled Substance, Drug, Device and Cosmetics Act. If an applicant has been convicted of any of the following within the preceding ten years, including the use of a vehicle to commit a felony or burglary or robbery, the driver would be disqualified. A driver applicant convicted of a sexual offense, a crime of violence or an act of terror would be disqualified. In accordance with the Code, criminal background and driver history checks will be conducted in the first year after engaging a driver and then every second year thereafter and all records of criminal history will be maintained for at least three years.
