
Pursuant to 52 Pa. Code § 5.591; Paragraph 33 of the Joint Petition for Approval of Settlement in the above-docketed proceeding (the “Joint Petition”), which was filed with the Pennsylvania Public Utility Commission (“PA PUC”) on March 25, 2024; and Paragraph 4 of the Final Order in the above-docketed proceeding, which was entered by the PA PUC on July 26, 2024, PECO Energy Company (“PECO” or the “Company”) hereby submits this Verification Statement and Verification acknowledging PECO’s compliance with each non-monetary remedial measure, both listed below and as set forth in Paragraph 31 of the Joint Petition. PECO hereby verifies that it has:

1. Implemented updates to its Storm Restoration Manual for Foreign Crews and Non Contractor of Choice (“COC”) Contractors, inclusive of subsections i. – v. of Paragraph 31(b) of the Joint Petition;
2. Provided its updated Storm Restoration Manual for Foreign Crews and Non COC Contractors (the “Revised Manual”) to all currently contracted foreign contractor companies on September 10, 2024, and requested acknowledgement of receipt of

the Revised Manual and distribution to employees, as outlined in Paragraph 31(b) – (c) of the Joint Petition; and

3. Developed and implemented a two-year Storm Foreign Contractor Inspection Pilot Program, incorporating subsections i. – v. of Paragraph 31(d) of the Joint Petition, to observe the worksites and work practices of foreign contractors during storm restoration efforts.
