Secretary Chiavetta:

On June 12, 2024, Administrative Law Judge Alphonso Arnold III (the “ALJ”) issued an Initial Decision (“ID”) dismissing the above-captioned Formal Complaint with prejudice. In the Secretarial Letter accompanying the ID, Exceptions to the ID were due within 20 days, or by July 2, 2024. Replies to any Exceptions were due within 10 days of the Exceptions due date, or by July 12, 2024. PPL Electric Utilities Corporation (“PPL Electric” or the “Company”) did not file Exceptions to the ID, nor was served with Exceptions by Jeffrey W. Smiles (“Complainant”) by the July 2, 2024 due date.

On October 28, 2024, PPL Electric received e-service of the Complainant’s Exceptions via the Pennsylvania Public Utility Commission’s (“Commission”) e-service account for the first time. The Complainant’s Exceptions were dated July 2, 2024, and appear to have been posted to the Commission’s electronic docket in the above-referenced proceeding on July 3, 2024. However, as PPL Electric was not served with the Complainant’s Exceptions until October 28, 2024, PPL Electric did not submit Replies to the Complainant’s Exceptions by the July 12, 2024 due date.

As such, pursuant to 52 Pa. Code § 1.15, PPL Electric respectfully requests that the Commission extend the deadline for filing Replies to the Complainant’s Exceptions to November 7, 2024, *i.e.*, 10 days after the Company was served with the Complainant’s Exceptions.
