**PETITION OF SUNRUN INC. TO WITHDRAW FROM PROCEEDING**

---

Pursuant to 52 Pa. Code § 5.41 Sunrun Inc. (“Sunrun”) submits this Petition to Withdraw as a party from the above captioned proceeding. In support of this Petition, Sunrun states the following:

1. On May 24, 2019, PPL Electric Utilities Corporation (“PPL”) filed its Petition for Approval of Tariff Modifications and Waivers of Regulations Necessary to Implement its Distributed Energy Resources Management Plan.
2. Sunrun filed a Petition to Intervene and Answer to PPL’s Petition on July 30, 2019.
3. ALJ DeVoe granted Sunrun’s Petition to Intervene on August 22, 2019.
4. On October 5, 2020, PPL, the Office of the Consumer Advocate, Natural Resources Defense Council, and the Sustainable Energy Fund filed a Joint Petition for Settlement of All Issues (“Joint Petition” or “Settlement”). Sunrun was not a party to the Joint Petition and did not join the Settlement.
5. ALJ Long and ALJ DeVoe issued a recommended decision to approve the Settlement (“Recommended Decision”) on November 17, 2020.
6. The Commission adopted the Recommended Decision and approved the Settlement on December 17, 2020.

7. On January 8, 2024, Tesla, Inc., Sunrun, Sun Directed, American Home Contractors, and the Solar Energy Industries Association submitted a Verified Petition of Joint Solar Parties for Rescission or Amendment of PPL Electric's DER Management Pilot.
8. On April 22, 2024, PPL filed its 2024 DER Management Plan Report.
9. PPL filed Petition of PPL Electric Utilities Corporation for Approval of its Second Distributed Energy Resources Management Plan on May 20, 2024. This matter was subsequently docketed as P-2024-3049223.
10. On May 23, 2024 the Commission denied the January 8, 2024 Petition of Joint Solar Parties.
11. On July 8, 2024, American Home Contractors, Inc., Enphase Energy, Inc., the Solar Energy Industries Association, SolarEdge Technologies, Inc., Sunnova, Inc., Tesla, Inc. and Trinity Solar, Inc. (the "Joint Solar Parties") filed a Petition to Intervene, Protest and Answer in Docket No. P-2024-3049223.
12. Sunrun does not seek intervention in Docket No. P-2024-3049223 and did not join the Joint Solar Parties' filing dated July 8, 2024.
13. On July 24, 2024, the OALJ issued a notice of prehearing conference Docket No. P-2024-3049223, for August 6, 2024. Sunrun did not participate in that conference.
14. Sunrun is no longer participating in Docket No. P-2019-3010128 and wishes to withdraw from this proceeding.
15. Sunrun's withdrawal will not cause undue delay or otherwise disrupt the orderly conduct of the proceeding, nor will it prejudice any party to the proceeding.
16. On August 13, 2024 Sunrun contacted the parties via email expressing its intent to withdraw from the proceeding. No party indicated an objection to Sunrun's withdrawal.

17. Based on the foregoing, Sunrun requests this Petition to Withdraw as a party from the above referenced proceeding be granted and that its representatives be removed from the Service List.
