



NOTICE OF ACQUISITION INVESTIGATION

November 15, 2024

To: Conneaut Lake Park Water Corporation Customers:

The PUC's Acquisition Investigation

Conneaut Lake Park Water Corporation, Inc. ("CLPWC") is your water service provider. CLPWC has approximately 163 customers and is regulated by the Pennsylvania Public Utility Commission ("PUC") under the Pennsylvania Public Utility Code. The PUC has opened an investigation at PUC Docket Nos. P-2024-3051855 and I-2024-3051857 into whether it should order a capable public utility to acquire CLPWC pursuant to Section 529 of the Public Utility Code (66 Pa. C.S. Section 529), which investigation shall include a discussion of alternatives to acquisition.

Notice of the Investigation and an Opportunity to Participate

As a customer of CLPWC, you are entitled to receive Notice of the Acquisition Investigation and an opportunity to participate in it.

You are not required to participate in the Investigation. The burden to prosecute the proceeding is with the PUC's Bureau of Investigation and Enforcement. Should you wish to participate, there are three ways to do so:

1. You can contact the Pennsylvania Office of Consumer Advocate ("OCA") with questions, concerns, and comments. The OCA is an active party representing the interests of residential customers. The telephone number for the OCA is (717) 783-5048 or toll-free (800) 684-6560. You can also find information about the case on the OCA's website: www.oca.state.pa.gov.

2. You can file a formal Petition to Intervene asking the PUC to allow you to be a party. The petition must state who you are, why you want to be a party, and what your specific concerns are. Petitions should include the docket numbers (P-2024-3051855 and I-2024-3051857) and be sent to the Secretary's Bureau, Pennsylvania Public Utility Commission, Commonwealth Keystone Building, 2nd Floor, Room N201, Harrisburg PA, 17120 with a copy to Administrative Law Judge's Arlene Ashton and Eranda Vero, Office of the Administrative Law Judge, 801 Market Street, Suite 4063, Philadelphia Pennsylvania 19107. Petitions must be received by the Secretary by close of business on December 5, 2024. CLPWC has the right to file a responsive pleading to any petition you file. If you have questions, please call the OCA.

3. You can attend or be a witness to a public input hearing, if one is held, where you will have the opportunity to present your views to Judges Ashton and Vero. All testimony given "under oath" becomes part of the official case record. If no public input hearings are held, you still have the right to attend any hearings that are held in the case; however, you will not be permitted to testify unless you have requested and been granted permission to intervene or are called by a party as a witness.


