NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from the final destination back to the carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest or TruckRouter.

0 - 20 miles	1/2 hour
21 - 40 miles	1 hour
41 - 60 miles	1 1/2 hours

For mileage in excess of 60 miles, a travel time charge of 1/2 hour will be assessed for each additional 20 miles.

NOTE 1 - Traveling charges (Column 1) are in addition to hourly rates (Columns 2, 3 and 4).

NOTE 2 - Hourly rates (Columns 2, 3 and 4) are based on the day or days as indicated, during which services are performed.

NOTE 3 - Hourly rates (Columns 2, 3, and 4) computed in quarter-hour periods; fractions of one-quarter hour considered as one-quarter hour.

NOTE 4 - Minimum Transportation Charge: Sundays and Holidays (any hour): 4 hours plus applicable travel charge at rates shown for day of the week services are performed during Peak Season and Non-Peak Season. Monday - Saturday (any hour): 3 hours plus applicable travel charge at rates shown for day of the week services are performed during Peak Season and Non-Peak Season.

NOTE 5 - Waiver of minimum charges - carrier convenience: Carrier shall not assess a minimum charge (number of hours) whenever a move is less than the minimum number of hours filed and said move is performed solely at carrier's convenience. In such instances, the carrier shall charge based on the actual time to complete the move plus applicable travel charge.

NOTE 6 - Regular work hours are 7:00AM to 7:00PM. Any moves performed Monday - Thursday outside those hours will be subject to the Friday & Saturday rates.

The following notes will apply to shipments transported forty (40) miles or less and shipments transported in excess of forty (40) miles:

NOTE 10 - In lieu of rates provided in tariffs, Tristate 50-T and Tristate 51-W, Full Value Protection with a \$250.00 deductible will be offered by this carrier at a rate of \$1.00 per \$100.00 of coverage subject to a minimum declared value of \$6.00 per pound based on the estimated weight (shipments transported 40 miles or less) or actual weight (shipments transported in excess of 40 miles).

NOTE 11 - A prepaid deposit of \$250.00 is required for moves utilizing 2 or 3 movers and \$500.00 for moves utilizing 4 plus movers.

Cancellation Policy: The prepaid deposit is not refundable if move is cancelled 3 days or less prior to the scheduled move date. Carrier reserves the option to waive the prepaid deposit or cancellation fee based on circumstances.
