

Pennsylvania Public Utility Commission NOTICE OF PRE-HEARING CONFERENCE AND DEADLINE FOR THE FILING OF PROTESTS AND PETITIONS TO INTERVENE

BACKGROUND

PECO was designated by PJM Interconnection, LLC (PJM), the regional electric transmission grid operator, to upgrade portions of the transmission system in Pennsylvania. As a result, on September 30, 2024, PECO submitted two applications to the Pennsylvania Public Utility Commission (PUC) for two proposed projects – the Brandon Shores Retirement Mitigation Project (Docket No. A-2024-3051467) and PJM 2022 Reliability Window #3 Project (Docket No. A-2024-3051463) – both in Peach Bottom Township, York County. The work in this area is necessary due to the retirement of Talen Energy's Brandon Shores Generating Station, a coal-fired electric power plant located in Maryland, as well as unprecedented growth of high energy data centers in Virginia and Maryland. These projects will help PECO maintain system reliability and provide additional capacity to meet the current and future needs of our customers in the area. The new electric transmission lines can also support the adoption and delivery of new cleaner energy resources, such as offshore wind and solar, and help meet the electric demands of electric vehicles.

PROCESS FOR PARTICIPATION

Formal protests and petitions to intervene must be filed in accordance with Title 52 of the Pennsylvania Code, on or before December 3, 2024. All filings must be made with the Secretary of the Pennsylvania Public Utility Commission, P.O. Box 3265, Harrisburg, PA, 17105-3265 and a copy must be served at PECO's Main Office Building located at 2301 Market Street, Philadelphia, PA, 19103.

DESCRIPTION OF THE PROJECTS

Over the next several years, PECO will be performing electric transmission infrastructure upgrade work primarily on existing PECO rights-of-way (ROWS) that span approximately five miles from the Pennsylvania/Maryland state line to PECO's existing substations in Peach Bottom Township and for short segments each less than 2 miles adjacent to PECO's existing ROWs. Work for these projects will include building and upgrading new 500 kV and 230 kV electric transmission lines, the expansion and upgrades of the existing Peach Bottom North and Peach Bottom South substations, and the construction, replacement, and modification of transmission lines and towers including replacing existing lattice structures with taller monopoles. Some of PECO's new transmission line infrastructure will interconnect with a new substation that will be constructed as part of a related project by a company not affiliated with PECO.
