

**STATUS REPORT OF DUQUESNE LIGHT COMPANY**


TO ADMINISTRATIVE LAW JUDGE MARY D. LONG:

Duquesne Light Company (“Duquesne Light” or the “Company”) submits the following Status Report, pursuant to the Interim Order Granting Motion For Continuance dated November 6, 2024, entered in this proceeding (“Interim Order”). The Interim Order required the parties to confer and agree on at least three alternate hearing dates when all parties and their witnesses are available for hearing and for Duquesne Light to file a status report on or before November 22, 2024, which reports the hearing dates agreed upon by the parties. Counsel for Duquesne Light has been in contact with the Complainant, Ms. Tonya Lee Brown, to discuss the directives of the Interim Order.
