WITNESSES: If you have any witnesses you want to have present during the hearing who are participating from a separate phone, you must provide them with the Conference and PIN numbers above.

TO CONSUMER COMPLAINANTS WHO WISH TO TESTIFY AT A PUBLIC INPUT HEARING: Please note that this is not the notice for the public input hearings, where consumers may give testimony regarding the proposed rate increase. Notice of the public input hearings will be published in advance of the hearings and will include instructions for how to register to testify at those hearings. It is anticipated that the public input hearings will be held in April 2023. You are not required to call in for the evidentiary hearings that will be held in June 2023.

FAILURE TO APPEAR: If you are an **Active Participant** in this proceeding, meaning that you advised the Administrative Law Judges that you wish to have an active role in this proceeding and submit evidence, witnesses and testimony in the technical evidentiary hearings, you may lose the case if you do not take part in this hearing and present evidence on the issue(s) raised. Your case may be dismissed “with prejudice” which means that you will be barred from filing another complaint raising the same claim(s) and issue(s) presented in the dismissed complaint.

CONTINUANCES. You may request a continuance of the hearing if you have a good reason. All continuances will be granted only for good cause. To request a continuance, you must submit a written request (a “motion”) at least five (5) days before the hearing. Your motion should include: 1) The case name, number, and hearing date; 2) The reason for the request; and 3) Whether the other party agrees (or if you do not know).

REPRESENTATION. If you are an individual, you may represent yourself or you may have an attorney represent you. All others, including a partnership, corporation, trust, association, or governmental agency or subdivision, must be represented by an attorney licensed to practice law in Pennsylvania, or admitted *pro hac vice*. Only an attorney may represent someone else.

PRESENTING EXHIBITS. If you intend to present any documents or exhibits at the hearing, you must email one (1) copy to the Presiding Officer Alphonso Arnold III at alphonarno@pa.gov and one (1) copy each must be sent to every other party. All copies must be received at least five (5) business days before the hearing. Proposed exhibits should be properly pre-marked for identification purposes.

ACCOMMODATION. Any party who needs an accommodation for a disability in order to participate in this hearing process may request one. Please call the OALJ scheduling office at least five (5) business days prior to your hearing to submit your request.

If you require an interpreter to participate in the hearing, please call the scheduling office at least ten (10) business days prior to your hearing to submit your request.
