



NOTE 5 - When a hot tub or safe (up to 300 pounds) is included in the shipment an additional handling fee of **\$500.00** per hot tub or **\$250.00** per safe will apply.

NOTE 6 - When at the convenience of the customer, shipment is held overnight, a charge of **\$150.00** per truck per night will apply.

NOTE 7 - Parking fees or tickets as well as tolls incurred by the carrier in the transportation of the shipment will be the responsibility of the customer. The charges for parking fees or tickets and tolls will be added to all other applicable charges. This note will apply to shipments transported forty (40) miles or less and shipments transported in excess of forty (40) miles.

NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from the final destination back to the carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest or TruckRouter.

21 - 40 miles	1 hour
41 - 60 miles	1 1/2 hours

For mileage in excess of 60 miles, a travel time charge of 1/2 hour will be assessed for each additional 20 miles.
