COMPLAINT

The Pennsylvania Public Utility Commission (Commission) is a duly constituted agency of the Commonwealth of Pennsylvania empowered to regulate public utilities within the Commonwealth. The Commission has delegated its authority to initiate proceedings which are prosecutory in nature to the Bureau of Investigation and Enforcement and other bureaus with enforcement responsibilities. Pursuant to that delegated authority and Section 701 of the Public Utility Code, the Bureau of Investigation and Enforcement Prosecutory Staff hereby represents as follows:

1. That NOAH DETWEILER, T/A NOAH ARTS, Respondent, maintains its principal place of business at 374 Dowling Road, Jamestown, Pa. 16134.
2. That Respondent was issued a Certificate of Public Convenience by this Commission on April 22, 2021, at A-2021-3025255 authorizing Respondent to transport, as a motor common carrier, property, excluding household goods in use, between points in Pennsylvania for compensation, at PUC No. 8924036.
3. That on July 28, 2021, the authority/certificate was dismissed due to non-compliance with PUC regulations regarding insurance.
4. That on September 26, 2024, PUC Enforcement Supervisor Ernest Snyder received information from PA State Trooper Chad Clemens, following a Driver/Vehicle Inspection Report about an uncertificated property carrier. Trooper Clemens transmitted the inspection report, which indicated that Respondent was transporting property from Sandy Lake, PA to Blain, PA. The Respondent communicated to Trooper Clemens that he applied for authority/certificate from the PA PUC but never received such authority/certificate.
5. That on September 26, 2024, PUC Enforcement Supervisor Ernest Snyder completed a Driver/Vehicle compliance Report (DVCR) which was mailed to the Respondent.
6. That Respondent is conducting transportation of property point to point in Pennsylvania without certificate/authority from the PA PUC in violation of 66 Pa.C.S. § 1101, 66 Pa.C.S. § 3310. The penalty for this violation as set forth in the Commission approved Motor Carrier Guidelines is \$1,000.

WHEREFORE, the Bureau of Investigation and Enforcement hereby requests that the Commission fine the Respondent, Noah Detweiler, T/A Noah Arts, the penalty of one thousand dollars (\$1,000.00) for the illegal activity described in this Complaint and order such other remedy as the Commission may deem to be appropriate.

NOTICE

- A. You must file an Answer within twenty (20) days of the date of service of this Complaint. The date of service is the mailing date as indicated at the top of the Secretarial Cover Letter for this Complaint and Notice, 52 Pa. Code §1.56(a). An Answer is a written explanation of circumstances wished to be considered in determining the outcome. The Answer shall raise all factual and legal arguments that you wish to claim in your defense and must include the reference number of this Complaint. Your Answer must be verified, and the original **shall be mailed to:**

If your Answer is 250 pages or less, you are not required to file a paper copy. If your Answer exceeds 250 pages, you must file a paper copy with the Secretary's Bureau.

- B. If you fail to answer this complaint within twenty (20) days, the Bureau of Investigation and Enforcement will request that the Commission issue a Secretarial Letter imposing a penalty. The penalty could include a fine, the suspension or revocation of your certificate of public convenience or other remedy.
- C. You may elect not to contest this complaint by paying the fine proposed in this Complaint by certified check or money order. Payment must be made to the **Commonwealth of Pennsylvania** and should be forwarded to:

- D. Your payment is an admission that you committed the alleged violation and an agreement to cease and desist from further violations. Upon receipt of your payment, the complaint proceedings shall be closed.
- E. If you file an Answer, which admits or fails to deny the allegations of the Complaint, the Bureau of Investigation and Enforcement will request that the Commission issue a Secretarial Letter imposing a penalty.

- F. If you file an Answer which contests the Complaint, the matter will be assigned to an Administrative Law Judge for hearing and decision. The judge is not bound by the optional fine set forth above.
