Application of the Gettysburg & Northern Railroad for crossing (DOT 593 389 G) alterations where Gardners Station Road (T 397) crosses, at grade, the tracks of Gettysburg & Northern Railroad, located in Tyrone Township, Adams County.

To Whom It May Concern:

By Secretarial Letter dated October 31, 2023, we directed the alteration of public crossing where (DOT 593 389 G) Gardners Station Road (T 397) crosses, at grade the tracks of Gettysburg & Northern Railroad (DOT 593 389 G) located in Tyrone Township, Adams County. All work at the subject crossing was to be completed on or before December 31, 2024.

By letter petition received on December 6, 2024, Gettysburg & Northern Railroad requests the Commission grant an extension of time in which to complete the project by December 31, 2025. Gettysburg & Northern Railroad avers that the completion date was not met due to funding delays.

We have carefully reviewed the record in this proceeding and will grant Gettysburg & Northern Railroad's letter petition for an extension of time to December 31, 2025.

**THEREFORE:**

The letter petition received December 6, 2024, from Gettysburg & Northern Railroad be and is hereby granted to the extent herein directed:

1. Paragraph 9 of our Secretarial Letter dated October 31, 2023, which reads as follows, to wit:

“9. The alteration of the crossing be completed on or before December 31, 2024, and that on or before said date Gettysburg & Northern Railroad, report in writing the date of actual completion of the work to this Commission and certify to the parties of record and this Commission that the work has been satisfactorily completed in accordance with this Secretarial Letter.”

be and is hereby modified to read:

9. The alteration of the crossing be completed on or before December 31, 2025, and that on or before said date Gettysburg & Northern Railroad, report in writing the date of actual completion of the work to this Commission and certify to the parties of record and this Commission that the work has been satisfactorily completed in accordance with this Secretarial Letter.

2. In all respects not inconsistent herewith, our Secretarial Letter dated October 31, 2023, remains in full force and effect.

The Parties are reminded that failure to comply with this or any Order or Secretarial Letter in this proceeding may result in an enforcement action seeking civil penalties and/or other sanctions pursuant to 66 Pa. C.S. § 3301.

All formal documents must be filed with the Secretary of the Commission. Documents must be eFiled, mailed or hand delivered. All filings should be addressed to the Secretary, PA Public Utility Commission, 400 North Street, Harrisburg, PA 17120. The Commission will not accept documents delivered by fax or by e-mail. Parties are encouraged to file formal documents by eFiling with the Secretary of the Commission by opening an eFiling account through the Commission's website (the account is free of charge) and accepting eservice at <https://www.puc.pa.gov/filing-resources/efiling/>.

If your filing contains confidential material, you are required to file by overnight delivery to ensure the timely filing of your submission. There are certain filings that cannot be eFiled, such as filings containing confidential or proprietary material. These must be submitted to the Secretary by overnight delivery, priority, or certified mail to allow tracking of your filing.

If you are dissatisfied with the resolution of this matter, you may, as set forth in 52 Pa. Code §§ 1.31 and 5.44, file a Petition for Reconsideration from Staff Action (Petition) with the Commission within twenty (20) days of the date of this letter. The Petition shall be eFiled with the Secretary of the Commission or sent to: Secretary, PA Public Utility Commission, 400 North Street, Harrisburg, PA 17120, and must be filed within twenty (20) days, or if no timely request is made, the action will be deemed to be a final action of the Commission.

The Petition MUST include: (1) a written statement (divided into numbered paragraphs) outlining the reasons for the request; (2) the case docket number (it is provided for you at the top right-hand corner of this letter); (3) the party on whose behalf the petition is made; (4) a Certificate of Service on the other parties of record; and (5) a Verification with original signature in accordance with 52 Pa. Code § 1.36.
