**WITHDRAWAL OF MOTION TO ASSIGN MATTER TO THE  
OFFICE OF ADMINISTRATIVE LAW JUDGE FOR DISPOSITION**

The Commonwealth of Pennsylvania, Department of Transportation (PennDOT), by its counsel, Karen L. Cummings, files this Withdrawal of Motion to Assign Matter to the Office of Administrative Law Judge for Disposition and represents as follows:

1. On December 17, 2024, PennDOT filed a Motion to Assign Matter to the Office of Administrative Law Judge for Disposition based on the following facts.
2. On July 7, 2021, PennDOT filed an application for approval to replace three existing above-grade crossings where State Route 0083 crosses the tracks of Norfolk Southern Railway Company (NS) in York County. The application was later amended to only include one bridge replacement at DOT # 501 500 G in Spring Garden Township.
3. After a field conference at which all parties agreed to the proposed bridge replacement, a Secretarial Letter documenting the parties' agreement was issued on February 16, 2023.
4. No party filed a Petition for Reconsideration from Staff Action within 20 days as required by the Secretarial Letter and in accordance with 52 Pa. Code §§ 1.31 and 5.44.

5. Pursuant to ordering paragraph 4 of the Secretarial Letter, PennDOT was ordered to prepare and submit complete detailed right-of-way plans and metes and bounds property descriptions for the Commission to appropriate to all parties for review and to the Commission for approval.

6. On August 28, 2024, PennDOT filed its complete detailed right-of-way plans and metes and bounds property descriptions with the PUC and provided a copy to Norfolk Southern.

7. NS did not file an objection to the plans or indicate its approval of the plans.

8. PennDOT moved to assign an ALJ because in order to move the matter to a final resolution.

9. PennDOT understands that the matter has been placed on the agenda for the Commission's December 19, 2024 public meeting and, as such, it is not necessary to pursue a referral to the ALJ.

**WHEREFORE**, PennDOT respectfully withdraws its request that this matter be assigned to the Office of Administrative Law Judge.
