
While the above-captioned was ongoing, Mr. Velez (the “Complainant”) was involved in a Commission small business mediation (SB-3050938) regarding similar subject matter to the Formal Complaint. The small business mediation proceeding has also been resolved.

Additionally, PPL Electric notes that its pre-served exhibits served on December 3, 2024, ahead of the December 10, 2024 evidentiary hearing, were inadvertently delivered to an incorrect email address not belonging to the Complainant. Furthermore, the pre-served exhibits were also transmitted via federal express to the mailing address indicated by the Complainant in the Formal Complaint, however, were not successfully delivered. Counsel for PPL Electric spoke to the Complainant about these service issues on December 18, 2024, which he acknowledged, but confirmed that he was satisfied with the outcome of the small business mediation and the above-captioned proceeding. Counsel for PPL Electric explained the Certificate of Satisfaction process to the Complainant, pursuant to 52 Pa. Code § 5.24(a), and the Complainant agreed to the filing of the instant Certificate of Satisfaction.
