▲ NOTE 1 - Minimum Transportation Charge: Any Day (any hour); Three (3) hours at rates named in Columns 2 or 3 plus applicable travel charge.

NOTE 2 - When a piano is part of a move, a flat charge of \$150.00 will be assessed in addition to the hourly rates shown above.

NOTE 3 - Carrier will assess an additional charge of \$10.00 per hour, or fraction thereof, for each flight above three flights. Each location of the move will be assessed separately.

◆ NOTE 4 - Where storage-in-transit is not unloaded at the carrier's warehouse and shipment remains on the carrier's vehicle overnight, an additional S.I.T. flat charge of \$250.00 per vehicle per night will be assessed.

NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2 and 3 will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from the final destination back to the carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest or TruckRouter.

0 - 15 miles	1/2 hour
16 - 30 miles	1 hour
31 - 45 miles	1 1/2 hours
46 - 60 miles	2 hours

For mileage in excess of 60 miles, a travel time charge of 1/2 hour will be assessed for each additional 15 miles.
