MOTION TO REQUEST FOR CONTINUANCE
Request to Postpone Telephonic Evidentiary Hearings for C-2024-3051044.

Please note that Complainants are currently before the state’s Supreme Court as it relates to the Commonwealth Court of Appeals (case # 865 C.D. 2024) regarding the PUC’s decision to dismiss linked case # C-2023-3041147.

As Pro Se defendants, Complainants respectfully and earnestly petition Administrative Law Judge Alphonso Arnold III to consider granting a continuance for the two Evidentiary Hearings scheduled on Jan. 9, 2025 (PUC case # C-2024-3051044). Complainants request that the Judge allows Complainants to first proceed with the upper court case without the overlap of this new formal complaint before the PUC, which formal complaint was only triggered by concerns that the utility company’s continued attempts to install a smart meter, regardless of it also being involved in the CWC Appeals case.

This new PUC case was triggered as a formal complaint against the utility’s repeated shutoff notices and workmen arriving about every 2 ½ weeks though we were all in the midst of the case before the CWCA. Although Complainants spoke by phone with the PUC secretary, who stated these attempts should not be happening at this time, Complainants wanted written evidence to feel comfortable that the utility company would finally halt its continued attempts to threaten shut off for not requesting the installation of a smart meter.
