Request for Information

- 1.) Question #1 and #4 of the application.

For your application to move forward, it needs to be amended with the correct name of the applicant (**Heartline Mobility LLC**) and with the correct PA Corporation ID #.

Please E-file a corrected first page of the application, write “Amendment to application A- 2024-3052695” at the top.

- 2.) Financial position (Balance sheet).

A.) Please provide a corrected Statement of Financial Position with assets and debts only HELD BY THE APPLICANT (**Heartline Mobility LLC**), and not any individual member. All Property must be registered or titled to **Heartline Mobility LLC** – personal property should not be included. In your data request reply, you provided a bank statement for an individual member of the LLC. The applicant is comingling its assets/debts with those of a LLC’s member, which is not permissible. Please ensure that the figures provided are accurate as of the date provided on the updated balance sheet, and that all figures provided are based on the best available information. Any assets which may need transferred to the applicant should happen prior to adding them to the balance sheet.

B.) At this point it is expected that the company is fully funded and ready to commence operations. To fully assist the Commission in determining your financial fitness please provide current copies of bank statement(s) (account numbers may be redacted), and/or notarized/official statement(s) provided by bank officers (with their current contact information) of account balance(s) in the name of the **Heartline Mobility LLC**.

C.) The registration of the vehicle provided did not show the name of the registered, as previously requested. Provide verifiable proof of ownership with a title and/or registration for any claimed vehicle(s) in the updated financial position showing the name of **Heartline Mobility LLC**.

NOTE: If this LLC has not yet been funded, then it should be NOW. If you are unable to provide a compliant balance sheet with verifiable proof, your application must be denied; as per 52 Pa. Code §41.14. It is the responsibility of the applicant seeking motor common carrier authority to demonstrate that it possesses the financial ability to provide the proposed service.
