The OSBA and Elverson Water Company, Inc. (“Elverson”), engaged in informal discovery and discussions. During these discussions, it was discovered that the proposed transaction encompasses no small business pipelines that are made with lead. As such, the OSBA does not wish to pursue this matter and has resolved its concerns. Therefore, the OSBA is withdrawing its Intervention in this matter.
