**INTERIM ORDER  
CONFIRMING REQUIREMENTS FOR EVIDENTIARY HEARING**

**YOU ARE DIRECTED TO READ THIS ORDER CAREFULLY AND IN ITS ENTIRETY. IT CONTAINS IMPORTANT INFORMATION REGARDING THIS CASE.**

The Parties were granted leave to conduct the hearing in this matter by written testimony. By Interim Order dated September 5, 2024, the Complainants were granted time to serve expert testimony by October 3, 2024; the Company additional rebuttal testimony by November 4, 2024. Motions, if any were due by December 4, 2024. The Parties in the above matter have exchanged written testimony. The following written testimony has been exchanged:

Complainants' Written Direct Testimony	Served March 30, 2020
Company Rebuttal Testimony of David R. Villao	Served May 20, 2024
Complainants' Surrebuttal	Served June 23, 2024

In accordance with the litigation schedule set forth in the Interim Order dated September 5, 2024, no further written testimony is to be served. No motions were filed on or before December 4, 2024, therefore this matter is ready to schedule for hearing.

The sole purpose of the hearing will be for each party to offer their written testimony for admission into the record. Either party may object to the offer of written testimony for admission into the record because the testimony is not admissible according to the Rules of Evidence. The Parties are expected to review and be familiar with the September 5, 2024, Interim Order as well as the other orders that have been issued in this matter.

THEREFORE,

IT IS ORDERED:

**1. DATE AND TIME OF HEARING:** An initial telephonic hearing will be held in this case on:

**Wednesday, March 12, 2025, beginning at 10:00 a.m.**

**2.** The Parties are reminded that the sole purpose of the hearing is for each party to proffer and authenticate the previously served written testimony for admission into the record. Either Party may object to the offer of previously served written testimony for admission into the record because the testimony is not admissible according to the Rules of Evidence.

3. That expert witnesses must be present at the hearing to authenticate their written testimony and answer questions about their written testimony. No written expert testimony will be admitted into the record if the expert witness does not appear at the hearing.

4. Following the hearing, the evidentiary record will be closed, and a decision will be rendered. I will not consider any evidence that is not presented at the hearing or that was not admitted into the evidentiary record.

5. That no continuances or extensions will be granted absent emergency circumstances that are verified by a third party.

6. That the failure to comply with any of the directives in this order may result in dismissal of the complaint.

7. That all other provisions of the July 25, 2024, Prehearing Order remain in effect.
