**ORDER GRANTING ADMISSION PRO HAC VICE**

On December 12, 2024, Michael A. Gruin, Esquire, legal counsel for Respondent and a member of the Bar of the Supreme Court of Pennsylvania (Attorney ID No. 78625), filed a Motion for Admission Pro Hac Vice of Natara Feller on behalf of nTherm, LLC (Motion), requesting that Natara Feller, Esquire, Feller Law Group, PLLC, 159 20<sup>th</sup> Street, Suite 1B, Brooklyn, NY 11232, be permitted to appear on behalf of Respondent, nTherm, LLC (Respondent or nTherm) in the above-captioned case, pursuant to 52 Pa.
