**Enclosed is a RATE CHANGE for the existing exception tariff, Tristate 54, Effective February 10<sup>th</sup>, 2025, for U-Relax Moving Co (PA PUC Certificate #A-8925359) in York PA.**

NOTE 4 - Minimum Transportation Charge: Sundays and Holidays (any hour): 3 hours at rates named in Columns 1 and 2.
