NOTIFICATION OF PROPOSED CONSTRUCTION

Pursuant to the requirements of 52 Pa. Code § 59.38, National Fuel Gas Distribution Corporation (“National Fuel”), hereby files the following Notification of Proposed Construction:

1. Description and Location of Proposed Work. National Fuel is planning to install approximately 4,500 of 6” plastic pipeline primarily along W. Lake Rd. in Fairview Township. The project will be bid out and awarded by National Fuel and constructed by a National Fuel approved contractor.
2. Type of Facility. 6.625” OD plastic gas facilities.
3. Estimated Starting Date. Construction is expected to begin on or about February 15th, 2025.
4. Estimated Completion Date. Construction is expected to be completed by May 5th, 2025.
5. Design Pressure. The pipeline will be designed for a maximum allowable operating pressure of 60 psig.
6. Estimated Cost. The cost of the pipeline project is \$497,000.

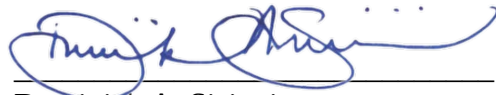

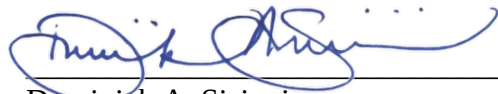
