STATUS REPORT OF PPL ELECTRIC UTILITIES CORPORATION

TO ADMINISTRATIVE LAW ALPHONSO ARNOLD III:

PPL Electric Utilities Corporation (“PPL Electric” or the “Company”) submits the following Status Report, pursuant to the Order Directing the Filing of Status Report dated November 25, 2024, entered in this proceeding (“Order”). The Order requires PPL Electric to file a Status Report no later than January 20, 2025, addressing the status of Mr. Medina’s OnTrack application and proposing the next procedural steps to be taken in this proceeding. Counsel for PPL Electric spoke with the Complainant on January 15, 2025, and can report that the Complainant submitted an OnTrack application on January 14, 2025, and that the application is currently under review. PPL Electric and the Complainant also discussed the status of the Complaint, and are in agreement that the litigation schedule in this case should remain suspended while the OnTrack application is pending. As such, PPL Electric respectfully requests that the Company provide a further Status Report to Your Honor in 30 days, by February 17, 2025, unless a Certificate of Satisfaction is filed in this proceeding indicating that the Complainant no longer wishes to pursue the Complaint.

PPL Electric will continue to work with the Complainant in an attempt to resolve this matter without the need for a formal evidentiary hearing and respectfully requests that Administrative Law Judge Alphonso Arnold III accept this Status Report.
