- 1 On January 17, 2025, Complainant is filing with the PUC an Affirmation That the Current Electric Meter Remains in Place During Ongoing Legal Proceedings.
- 2 Complainant has been informed by the PUC Office of Special Assistants that her current electric meter will remain in place during her ongoing case.
- 3 Complainant now respectfully affirms this.
- 4 Complainant intends to submit an Appeal to the Commonwealth Court of Pennsylvania.
- 5 The current meter should remain in place until final disposition in this case is made at the appellate court level, whether it be the Commonwealth Court or the Supreme Court of Pennsylvania.
- 6 In addition, other legal actions are in process whose outcomes may well affect the path forward of Complainant's case, including:

**6.a** *Hughes v. PA Pub. Util. Comm'n*, Docket No. 543 MAL 2024, pending in Pennsylvania Commonwealth Court.

**6.b** Case pending in the Pennsylvania Commonwealth Court after *Jeannette and Craig Pavlick v. West Penn Power Company*, Docket No. C-2018-3002723.

**6.c** Case pending in the Pennsylvania Commonwealth Court after *Andrew and Theresa Sabatini v. West Penn Power Company*, Docket No. C-2018-3005177.

**6.d** *James and Teresa Mendez Quigley vs. PUC*, Docket No. 1180 CD 2024, pending in Pennsylvania Commonwealth Court.

**6.e** *Jack Kline vs. PUC*, Docket No. 918 CD 2024, pending in Pennsylvania Commonwealth Court.

**6.f** *Judith Hendin vs. PUC*, Docket No. 766 CD 2024, pending in Pennsylvania Commonwealth Court.

**6.g** *John Chenosky vs. PUC*, Docket No. 1383 CD 2024, pending in

Pennsylvania Commonwealth Court.

**6.h** Other PUC Complaints that were dismissed before mine and are at various stages in the Pennsylvania Commonwealth Court.

**6.i** Decision pending in the Declaratory Judgment of Petitioner Nancy Colbert. The Commonwealth Court sent this case on to the Supreme Court of Pennsylvania (Supreme Court 96 MAP 2024).

- 7 Complainant respectfully requests that the current meter remain in place, not only during her ongoing legal proceedings, but also until these other legal actions are completed in full because they may affect her own case.
- 8 In leaving the current meter in place, Duquesne Light Company will not be harmed since Complainant has never missed a monthly payment and will continue to pay her electric bills on time each month.
- 9 Therefore, Complainant affirms that Duquesne Light Company will allow the current electric meter to remain in place during Complainant's ongoing case. The current electric meter will stay in place until: (1) a final disposition of her case is made at a higher court; and (2) final decisions are rendered in related cases, named *supra*, as these may affect the legal path forward for Complainant.
