POST HEARING ORDER

This Order is being issued pursuant to my authority as Presiding Officer to regulate the course of a proceeding. *See* 52 Pa. Code § 5.483(a).

On January 16, 2025, an evidentiary hearing was held in the above captioned matter. Both parties participated in the hearing and presented evidence on the issues raised. The evidentiary record was not closed at the conclusion of the hearing.

During the hearing, Mr. Briner requested and was permitted the opportunity to submit late-filed exhibits. Mr. Briner indicated that he intended on having an electrical inspection performed of the appliances in his home, and that he would submit the results as late-filed exhibits. This Order memorializes the discussion held at the hearing concerning the submission of late-filed exhibits.

In addition, **this Order also requires that Mr. Briner submit a resume or curriculum vitae of the electrician who performs the inspection**, alongside the submission of the late-filed exhibits.

ORDER

THEREFORE,

IT IS ORDERED:

1. That Christopher Briner has until **February 13, 2025**, to submit late-filed exhibits in the above captioned matter, consistent with the discussion held during the evidentiary hearing in this matter and the discussion in this Order.

2. That the resume or curriculum vitae of the witness who sponsors the late-filed exhibits shall be submitted alongside the submission of the late-filed exhibits.

4. That PPL Electric Utilities Corporation has until **March 6, 2025**, to submit objections to the late-filed exhibits submitted by Christopher Briner.
