

NOTIFICATION TO IDENTIFY STOCKHOLDERS

1. Gardner Moving Company is a Pennsylvania business corporation having its principal office at 757 Millers Run Road, McDonald, PA 15057. Gardner Moving Company (hereinafter referred to as GMC) holds operating authority from the Pennsylvania Public Utility Commission at Docket A-00108945 to transport household goods in use between points in Pennsylvania.

2. As of January 1, 2024, the shares of stock of GMC were held as follows:

WHEREFORE, Gardner Moving Company, by this notice, desires to inform the Pennsylvania Public Utility Commission as to the current stock ownership of this utility.


