Common/ Contract Carrier of Household Goods in Use.

1. This application is required to request a Certificate of Public Convenience (for Common Carriers) or Permit (for Contract Carriers) to operate as a commercial carrier of household goods in use.
2. Upon approval of the application, you will be notified that prior to providing service in Pennsylvania you must submit evidence of insurance to the Public Utility Commission. Your permanent evidence of insurance will be a Form E for bodily injury and property damage insurance. This form is mailed to the Commission directly from the home office of your insurance carrier. The name and address on your Form E must exactly match the name and address you have provided on your application. Your insurance company must subscribe to the NIC Insurance Filing website at www.nicinsurancefilings.com. You will request the insurance company (not the agent) to file the required insurance forms electronically through NIC. Mailed insurance forms are no longer acceptable. The minimum limits of insurance are as follows:

Bodily Injury - The liability of the insurance company on each motor vehicle operated in common or contract carrier service shall be in amounts not less than \$300,000 per accident for a vehicle with a manufacturer's gross vehicle weight rating of 10,000 pounds or less, in the case of a single vehicle, or a manufacturer's gross combination weight rating of 10,000 pounds or less, in the case of an articulated vehicle. The liability of the insurance company on each motor vehicle operated in common or contract carrier service shall be in amounts not less than \$750,000 per accident for a vehicle with a manufacturer's gross vehicle weight rating over 10,000 pounds, in the case of a single vehicle, or a manufacturer's gross combination weight rating over 10,000 pounds, in the case of an articulated vehicle. Insurance coverage of motor carriers of household goods shall meet the requirements of 75 PA C.S. §1711 (relating to required benefits).

3. - Both owners of the LLC, Keith Davis and Adam Jovicevic began working with a company on "Moving Helper". Moving Helper is a company that partners with the company U-Haul so that whenever a customer of U-Haul is in need of moving assistance (carrying goods from their home, storage unit, or truck to another place) they can hire a company from Moving Helper. In 2022 both owners of the LLC began working with a company called "Stress Free Moves" that is affiliated with Moving Helper. We learned tons of aspects of moving while working with that company such as; learning how to correctly carry different type of furniture, how to assemble and disassemble different types of furniture, use of blankets to protect furniture while the truck drives, how to use a dolly properly, how to use a ratchet strap and rope that ensure goods in the truck do not move around in the truck while it drives. Both owners of the LLC, Adam Jovicevic and Keith Davis worked with this company from beginning of 2022 - end of 2023. After this is when we started our own company ManPower Moving LLC with the Moving Helper Company. Since the end of 2023 until now we have helped over 300+ customers with their move. We also have accumulated 80+ 5 star reviews that we have attached with this application. Since running our own business with the Moving Helper Company we have learned how to manage customer communication and employee communication so that everyone is on the same page and there are no hiccups with the job that needs to get done. We also learned to

manage the finance side of things such as making sure we make enough profit from each job to keep the business running properly as well as buying the right tools and materials to help our employees be prepared for any situation.

We have printer/copier to keep physical records of everything that happens within the business (Customer information, job details such as locations, the amount of furniture and boxes need to be moved, and what 1099 contractors we have on such job) Our place to maintain records for the PUC first comes online with google. We keep all of our information on either google docs or google spreadsheets. We also make hard copies of all of these details to keep in a filing cabinet in our office. Our communication network with clients and 1099 contractors we hire is all through text message or phone call. Our two main sources to receive customer requests will be through facebook business page and google business page. We hope to grow to a point where we can have a physical aspect to our advertising (Billboards, physical signs). Our business hours will be 7:00 am - 7:00 pm.

5a. - Our hiring standards for drivers will begin with several interviews from the owners to see if their personality is right for our company and for that position. We are looking for applicants with driving experience (Delivery driver, uber, taxi, door dash driver, bus driver). Then we will conduct a background check on their driving history. We can do this by having their permission and after gaining permission we can submit a request through our local department of motor vehicles. If their driving history is sufficient (No or low amount of tickets, accidents or any other violations) Either owner of our company (Keith Davis or Adam Jovicevic) will then take said applicant on several driving tests in a car to see if they are even suitable to drive a smaller vehicle based on our opinion.

5b. - The way our company will conduct background checks will first be to have a policy outlining our background check procedures. We will then receive written permission from said employee that the background check will be conducted on as well as any and all personal information they can provide us. After that we will use GoodHire Background Checks online service to then finally conduct the background check.

5c. - Our driver training program will take up to two weeks depending on how comfortable either owner feels about said trainee and their ability to drive the truck. It will entail different driving possibilities to ensure the driver is prepared for any and all circumstances. This will include driving on the highway, back roads, dirt roads, and city driving and parking. The driver will learn how to maneuver the truck in all situations including day, night, and rain. Once the driver has demonstrated their ability to drive in all these circumstances we will then grant them driver capability.

5d. This was detailed in 5a, but to repeat, we will have permission from the driver to submit a request with the local department of motor vehicles.

5e. All employees, especially drivers, drug use of any kind will be prohibited. We will ensure this by regular and random drug tests. Alcohol will be prohibited for drivers but never the day before a job they must drive or before any time they do drive. We will allow anytime 24 hours or before a job that alcohol will be permitted. If we discover that they drank within the 24 hour time frame before a job that will result in immediate termination of said employee.

6. We will begin with just one 15 foot box truck. This will be appropriate for the territory we will be serving because we will never do more than one moving job per day. This ensures we will always have a truck available for any job we have booked.

7a. Our vehicle safety program will first entail things that can be done without a professional such as tire pressure checks before and after any job, oil check and coolant check before and after any job. If the truck has a check engine light before a job begins we will use an ODB scanner that can run diagnostics on vehicles to address the problem. If the problem is unsafe for the vehicle to drive, we will reschedule the move scheduled for that day. We will have a mechanic that will check on the truck every 10,000 miles to ensure all components of the vehicle are operating smoothly and with code to the Pennsylvania department of motor vehicles.

7b. Our system to ensure our vehicle will comply with the Pennsylvania vehicles equipment standards will rely on our truck mechanic specialist every 10,000 miles so that if anything doesn't fit the vehicle equipment standards then that truck will be out of commission until said standards are reached.
