By this letter, Veolia Water Pennsylvania, Inc.'s ("VWPA") hereby withdraws its December 9, 2024 Petition for Reconsideration of Staff Action and Request for Temporary Extension of Final Resolution (the "Petition") with regard to the above-referenced matter.

Following technical discussions with Norfolk Southern Railway Company ("Norfolk") regarding the proposed alteration and the matters raised by VWPA in its Petition, Norfolk has affirmed that it will communicate the installation method to be used for the project with VWPA prior to commencing the work after it has selected a contractor for the project. Additionally, Norfolk has confirmed that VWPA's existing facilities not previously shown in Exhibit B to the application have been added to its plans to ensure VWPA's critical infrastructure is not impacted by the project.
