



NOTE 3 - Hourly rates (Columns 2, 3, and 4) computed in quarter-hour periods; fractions of one-quarter hour considered as one-quarter hour.

NOTE 4 - Hourly rates are calculated from the time the vehicle & crew arrive at client's address at the first point of origin and ends at the time the vehicle & crew depart the client's final delivery address.

NOTE 5 - Minimum Transportation Charge: Sundays and Holidays (any hour): 4 hours plus applicable travel time charge at rates named in Columns 1 and 4. Fridays & Saturdays (any hour): 2 hours plus applicable travel time charge at rates named in Columns 1 and 3. Monday-Thursday (any hour): 2 hours plus applicable travel time charge at rates named in Columns 1 and 2.

NOTE 6 - When an additional truck is required, the additional charge is **\$250.00** per truck per day.

NOTE 7 - When requested by customer or required, additional charge for overnight storage/holding fee is **\$350.00** per truck per night.

NOTE 8 - Any parking fees incurred by the carrier at client's origin or destination will be the responsibility of the client and added to the carrier's charges.

NOTE 9 - All reservations for full service moves require a deposit equal to one hour of the job's labor rate. Deposits are fully refundable if the job is cancelled by the client at least 48 hours prior to the scheduled reservation. The deposit is forfeited if the client cancels the job within 48 hours of the scheduled reservation.

NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from the final destination back to the carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest or TruckRouter.

0 - 15 miles	1 hour
16 - 30 miles	1 1/2 hours
31 - 40 miles	2 hours

For mileage in excess of 40 miles, a travel time charge of 1/2 hour will be assessed for each additional 20 miles.

NOTE 4 - OVERTIME LOADING/UNLOADING (Item 240) - Rates shown in Allegheny County will apply for all counties in Pennsylvania.

NOTE 5 - ELEVATOR, STAIR CARRY, EXCESSIVE DISTANCE (Item 260) - Rates shown under Schedule D will apply for all counties in Pennsylvania.
