Tariff Naming Rates, and Rules and Regulations Governing the
Transportation of Persons in Paratransit Service Between Points in Pennsylvania

To transport, as a common carrier, by motor vehicle, persons in paratransit service, limited to non-emergency medical transportation authorized under the Medical Assistance Transportation Program (MATP), between points in the City and County of Philadelphia, and from points in the City and County of Philadelphia, to points in the Counties of Bucks, Chester, Delaware and Montgomery, and return.

RULES & REGULATIONS

1. Advance reservations are required and must be made one (1) hour prior to service being rendered.
2. Rates for mileage are determined by GPS mapping software and will be calculated from the passenger's pick-up (point of origin) to the passenger's drop-off (point of destination).
3. Additional expenses necessitated by or incurred at the request of the passengers, including but not limited to, highway tolls, bridge tolls, entrance fees and parking, shall be added to the charge of the trip. Expenses for driver's lodging and meals while on trips out of town which are in excess of ten (10) hours will be added to the basic charge.
4. If any trip requires the vehicle and driver to remain at a destination overnight, or at any point en route to a destination overnight, the patron will be responsible for providing carrier's driver with accommodations at an overnight facility (motel, hotel) being utilized by the patron, and all meals required by the carrier's driver. Expenses for driver's lodging and meals while on trips out of town which are in excess of ten (10) hours will be added to the basic charge.
5. Trips on the following Holidays are subject to Additional fees as listed in RATES:
 - New Year's Eve and New Year's Day
 - Memorial Day
 - Independence Day
 - Labor Day
 - Thanksgiving Day and Black Friday (Day after Thanksgiving)
 - Christmas Eve and Christmas Day
6. **CONTRACT SERVICES**

Contract services will be for a term of not less than 30 days for pre-qualified persons under a federal, state, county or municipal government agency contract. Rates for the services will be specified in the respective contracts, copies of which, including any amendments thereto, are to be filed with the Commission as executed to become effective on one day's notice.

SCHEDULE OF RATES
(Per Person)

The trip will be billed based on a Flat Point to Point rate, Hourly rate, or Mileage rate. Most trips will involve flat point to point rates based on mileage and estimated time required for the trip. Contact us and we will provide you with the exact flat point to point rate in advance. Hourly rates will be used for certain trips that may involve roads with lower speed limits and more traveling and waiting time. Mileage rates will be used for complex trips where the other rate options do not apply. Please call us to explain your trip and we will determine the type of rate and pricing that applies. We will determine the pricing structure with you that applies before your trip and before charging you. We will not combine pricing structures/options and we will not use loaded miles.

Flat Point to Point Rates – The carrier will work with the customer to establish point to point rates for service from the point of pickup to point of drop-off (one way). Point to point rates will be based on mileage, time required to provide service, and complexity of the service requested.

Hourly Rate: Certain trips will require hourly rates (with a 15-minute minimum block):

Standard Hours:	8:00 AM to 6:00 PM	
Van:	\$ 70.00/hr	(\$17.50 per 15 min.)
Evening Hours:	6:00 PM to 8:00 AM	
Van:	\$ 80.00/hr	(\$20.00 per 15 min.)
Weekend Hours:	Saturday 12:01 AM to Monday 7:59 AM	
Van:	\$ 80.00/hr	(\$20.00 per 15 min.)
Holidays:	12:01 AM to 11:59 PM	
Van:	\$100.00/hr	(\$25.00 per 15 min.)

Mileage rate: \$4.50 per mile, or any fraction thereof.

Reservations: Any Reservation made less than one (1) hour before travel time will be charged an additional \$50.00 fee.

Waiting Time at Origin: There will be no charge for the first five (5) minutes that the Carrier must wait for a customer beyond the scheduled pick-up time. Any additional waiting time will be charged at the rate of \$2.50 per 15 minutes, per person, or any fraction thereof.

Waiting Time During Trip: If Carrier is requested to wait for customer at destination or during a trip, there will be an additional waiting time charge of \$15.00 per 30 minutes, per person, or any fraction thereof.

Deadhead Fee: If a client lives 20 miles or more to pick up for transportation, we will charge \$2.75 per mile to drive to their home to pick them up.

No-shows/Late cancellations - \$25.00 fee
