**INTERIM ORDER  
DIRECTING THE FILING OF SECOND STATUS REPORT**

This matter concerns a Petition filed by CSX Transportation, Inc. on January 29, 2025, with the Pennsylvania Public Utility Commission (“Commission”). In its Petition, CSX requested that maintenance responsibility for the bridge structure where Bort Road (T-270) crosses above CSX’s tracks in Northeast Township, Erie County (“the Township”), be reassigned from it to the Township. For a more extensive procedural history of this case, the reader may turn to “Interim Order Granting Motion For Continuance And Directing The Filing Of Status Report”, dated August 19, 2024. The parties participating in this proceeding are CSX, Northeast Township, Erie County, and the Pennsylvania Department of Transportation.

On January 28, 2025, the parties participated in a status conference to discuss the status of this case.<sup>1</sup> This Order will direct the parties to file a Status Report by March 28, 2025, as agreed to during the off the record conference. The Status Report should propose the next procedural steps to be taken in this proceeding.
