The evidentiary hearing in the above referenced proceeding is currently scheduled for Wednesday, February 12, 2025, at 10:00 AM. Unfortunately, Counsel for Duquesne Light Company (“Duquesne Light” or “Company”) has an unavoidable scheduling conflict with the hearing date. Specifically, Counsel for Duquesne Light has evidentiary hearings scheduled for another matter before the Public Utility Commission (“Commission”) from 10:00 AM to 4:00 PM on February 11, 12, and 13. 
