
The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

NOTE 1 - Traveling charges (Column 1) are in addition to hourly rates (Columns 2, 3 and 4).

NOTE 2 - Hourly rates (Columns 2, 3 and 4) are based on the day or days as indicated, during which services are performed.

NOTE 3 - Hourly rates (Columns 2, 3, and 4) computed in quarter-hour periods; fractions of one-quarter hour considered as one-quarter hour.

NOTE 4 - Minimum Transportation Charge: Sundays and Holidays (any hour): 4 hours at rates named in Columns 1 and 2. Fridays and Saturdays (any hour) or Monday-Thursday (any hour): 4 hours at rates named in Columns 1 and 4.

NOTE 5 - When a spinet/console piano or gun safe is part of the shipment, carrier will assess the following charges in addition to the applicable hourly rates published herein:

SPINET/CONSOLE PIANO - \$100.00

GUN SAFE - \$100.00

Carrier does not move upright, baby grand or grand pianos.

NOTE 6 - Tolls and/or parking permits/tickets incurred by the carrier when transporting the shipment will be the responsibility of the shipper and added to the final charges.

NOTE 7 - When overnight holding on the truck is requested for the convenience of the shipper, additional cost is **\$150.00** per night per truck.

NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from final destination back to carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest, or TruckRouter.

0 - 15 miles	1/2 hour
16 - 30 miles	1 hour
31 - 50 miles	1 1/2 hours

For mileage in excess of 50 miles, a travel time charge of 1/2 hour will be assessed for each additional 20 miles.
