On July 17, 2024, the Secretary's Bureau acknowledged that it erred in interposing Comcast's name on Mr. Bankowski's Formal Complaint but stated that, because the Complaint was already assigned to the Commission's Office of Administrative Law Judge, the Secretary's Bureau was no longer the appropriate entity to rectify the misidentification.

7. Mr. Bankowski did not name Comcast in this case, nor did he intend to name Comcast, and he does not wish to pursue any case against Comcast.

8. Mr. Bankowski still wishes to pursue this case against Consolidated/Fidium.

9. Comcast does not own Consolidated/Fidium.

10. Comcast has no affiliation with Consolidated/Fidium.

**WHEREFORE**, the Parties stipulate as follows:

A. Mr. Bankowski's Formal Complaint is dismissed with respect to Comcast;

B. Mr. Bankowski wishes to pursue his Formal Complaint against Consolidated/Fidium only, and not Comcast.
