NOTE 2 - Hourly rates (Columns 2 and 3) are based on the day or days as indicated, during which services are performed.

NOTE 3 - Hourly rates (Columns 2 and 3) computed in half-hour periods; fractions of one-half hour considered as one-half hour.

NOTE 4 - Minimum Transportation Charge: Saturdays, Sundays and Holidays (any hour): 4 hours at rates named in Columns 1 and 2 plus applicable travel time charge. Monday-Friday (any hour): 3 hours at rates named in Columns 1 and 3 plus applicable travel time charge.
