
The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

NOTE 1 - Minimum Transportation Charge: Sundays and Holidays (any hour): Three (3) hours at rates named in Columns 1 and 2.

Weekdays and Saturdays (any hour): Two (2) hours at rates named in Columns 1 and 3 or 4.

▲ NOTE 2 - When a Spinnet, Console or Upright Piano or Gun Safe (350 pounds or over) are included in the shipment, an additional handling fee of **\$250.00** per item will apply. If stairs are at either origin or destination, an additional fee of **\$100.00** per flight will apply. These fees are in addition to all other applicable charges.

NOTE 3 - When shipment needs to be held overnight for the convenience of the customer, an overnight holding fee of **\$250.00** per truck per night will apply in addition to all other applicable charges.

NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2 and 3 will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from the final destination back to the carrier's terminal terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest or TruckRouter.

**0 - 40 miles                      1 Hour**

For mileage in excess of 40 miles, a travel time charge of 1/2 hour will be assessed for each additional 20 miles.
