Dear Mr. Chen:

On February 5, 2024, Keystone Appalachian Transmission Company (KATCo) and FirstEnergy Pennsylvania Electric Company (FE PA) filed a joint Letter of Notification for approval to construct the Grand Point – Guilford 138 kV Transmission Line Tap in Franklin County, Pennsylvania. In order for us to complete our analysis of the subject application, the Bureau of Technical Utility Services requires answers to the enclosed data requests. This information is necessary for completion of our review of the filing.

Please forward the requested information to the Secretary of the Commission **within ten (10) days** of receipt of this letter. Failure to respond may result in the Letter of Notification being denied. As well, if KATCo or FE PA has decided to withdraw its filing, please reply notifying the Commission of such a decision.

The Commission strongly encourages submission through efilng with the Secretary of the Commission by opening an efilng account through the Commission’s website and accepting eservice at <https://efiling.puc.pa.gov>. The Commission is accepting all public documents through our efilng system at this time.

If your filing contains confidential material, you are required to either file by overnight delivery or submit to the Secretary’s Share Point File system to ensure the timely filing of your submission. Filers should contact the Secretary’s Bureau in advance to gain access to the Share Point File system. Make sure to reference the Docket Number listed above when filing your response and mark the materials “CONFIDENTIAL” in bold or highlighted manner if any of the requested information is deemed to be of a confidential nature.


Your answers should be verified per 52 Pa Code § 1.36. Accordingly, you must provide the following statement with your responses:
