List of Changes Made by This Tariff

The following changes are made through this tariff filing:

1. The flag drop has been increased from \$2.00 to \$3.00.
2. The rate for the fractional miles has increased to \$.45 for each fractional 1/10th.
3. A change in credit card usage fee will be imposed at the time of payment and will be imposed upon all credit card charges in excess of \$10.00. The processing fee will be added by the credit card company and is not collected by Pocono Mountain Transportation.

The following symbols shall be used in this tariff for the purpose indicated below:

- (R) to signify reduction
- (A) to signify increase
- (C) to signify change

Operating Authority

To transport, as a common carrier, by motor vehicle, persons upon call or demand service, from points in the counties of Monroe, Pike and Carbon; the boroughs of Wind Gap, Pen Argyl and Bangor, and the townships of Plainsfield, Washington and Upper Bethel, all in Northampton County, to points in Pennsylvania, and return, excluding service that is under the jurisdiction of the Philadelphia Parking Authority.

Schedule of Rates

First 1/10 th mile or fraction thereof (flag drop)	\$ 3.00 (A)
Each additional 1/10 th mile or fraction thereof	\$.45 (A)
Waiting time: Each minute or fraction thereof:	\$.85 (A)

On all trips between the hours of 10:00 pm and 6:00 am a charge of \$ 3.00 will be added (A)

An Additional charge of \$ 3.00 per trip will be added on the following holidays: (A)

- New Year's Eve after 5:00 pm
- New Year's Day
- Easter
- Memorial Day
- July 4th
- Labor Day
- Thanksgiving
- Christmas Eve after 5:00 p.m.
- Christmas Day

A minimum charge of \$10.00 will be imposed upon all credit card charges.

For all credit card charges there will be a fee associated which in turn is NOT collected by Pocono Mountain Transportation, Inc. The fee goes directly to the Credit Card Company.
