On November 25, 2024, the Pennsylvania Public Utility Commission (Commission) received American Wholesale Energy Inc.'s Application for an Electric Generation Supplier (EGS) license. On December 6, 2024, the Commission served a Deficiency Secretarial Letter requesting missing or incomplete information. On February 4, 2025, American Wholesale Energy Inc. filed responses to the Deficiency Secretarial Letter. In order for us to complete our analysis of American Wholesale Energy Inc.'s EGS Application, the Commission's Energy Industry Group requires answers to the attached questions.

Data Requests

1. Reference Application, Section 3.a, Affiliates – Applicant failed to list its parent company, ONIT Energy Ltd., and its affiliates in this section. Please file an updated Application page with the information requested.
2. Reference Application, Sections 5.b and 5.c, Customer/Regulatory/Prosecutory Actions – Applicant stated: “American Wholesale Energy has no escalated actions or complaints and have never been previously registered with the Pennsylvania PUC”. There appears to be a proceeding filed against the applicant’s parent company, ONIT Energy Ltd. by the Ontario Energy Board (OEB). Specifically, the OEB conducted an inspection of ONIT Energy Ltd.’s marketing practices which resulted in an Assurance of Voluntary Compliance, dated April 9, 2021, at OEB File No. EB-2021-0116. If this case involves either the applicant, its parent company, any affiliates, and/or people listed in the application, please resubmit the application with Sections 5.b and 5.c fully disclosed. Applicants must list and identify all such proceedings (active or closed within the last five years), by name, subject and citation; whether before an administrative body or in a judicial forum. Also, provide a statement as to the resolution or present status of any such proceedings listed.
3. Reference Application, Section 7.b, Financial Fitness – Please provide three recent consecutive months of the applicant’s bank statements.
