



STATUS REPORT OF PPL ELECTRIC UTILITIES CORPORATION

TO ADMINISTRATIVE LAW ALPHONSO ARNOLD III:

PPL Electric Utilities Corporation (“PPL Electric” or the “Company”) submits the following Status Report, pursuant to the Order Directing the Filing of Second Status Report dated January 21, 2025, entered in this proceeding (“Order”). The Order requires PPL Electric to file a Status Report no later than February 17, 2025, addressing the status of Mr. Medina’s OnTrack application and proposing the next procedural steps to be taken in this proceeding. Counsel for PPL Electric can report that the Complainant’s OnTrack application was accepted and that he is currently enrolled in OnTrack. PPL Electric is continuing to work with the Complainant in an attempt to resolve this matter without the need for a formal evidentiary hearing. As such, PPL Electric respectfully requests that the litigation schedule in this case remain suspended while the parties pursue settlement and that the Company provide a further Status Report to Your Honor in 30 days, by March 17, 2025, unless a Certificate of Satisfaction is filed in this proceeding indicating that the Complainant no longer wishes to pursue the Complaint. PPL Electric respectfully requests that Administrative Law Judge Alphonso Arnold III accept this Status Report.
