**INTERIM ORDER  
GRANTING MOTION FOR FURTHER CONTINUANCE**

A hearing was scheduled in the above matter for February 19, 2025. On February 12, 2025, Ms. Brown requested to cancel the hearing. On February 17, 2025, she explained that she wanted a continuance until her petition for bankruptcy was confirmed. Duquesne Light did not object to the cancellation and continuance of the hearing. I granted the request by email. February 19, 2025, hearing was cancelled by hearing notice issued on February 18, 2025.

THEREFORE,

IT IS ORDERED:

1. That the motion for a continuance by Tonya Lee Brown is granted.
2. That the Ms. Brown is directed to remain in contact with counsel for Duquesne Light, Ms. Rulli, and inform Ms. Rulli of the status of her bankruptcy petition.
3. That on or before **April 4, 2025**, counsel for Duquesne Light shall file a joint status report that provides an update and recommends further proceedings. In the event that

a certificate of satisfaction is filed, or Ms. Brown otherwise withdraws her complaint, no status report shall be necessary.

4. That the parties are reminded that Commission policy encourages settlement and that they should continue to communicate with each other in an attempt to resolve their dispute.

5. That all other provisions of August 21, 2024, Prehearing Order remain in effect.
