Windstream Communications, LLC (“Windstream”) is in receipt of the Preliminary Objection filed by PPL Electric Utilities Corporation (“PPL”) at Docket No. C-2025-3053002 on February 10, 2025. In its Preliminary Objection, PPL asserts that Windstream was not joined as a necessary party and should, therefore, be joined to the complaint served on PPL at C-2025-3053003 on January 21, 2025.

On January 21, 2025, Windstream was served by the Commission an identical but separately docketed complaint of Robert Glozzer at Docket No. C-2025-3053003. Windstream and Mr. Glozzer have resolved all allegations involving Windstream following the replacement of Windstream’s poles at Mr. Glozzer’s service address. As a result, Windstream submitted a Certificate of Satisfaction of the Complaint at Docket No. C-2025-3053003 on February 5, 2025. 


